Introduction

This report summarises the activity of the Moorabbin Airport Community Aviation Consultation Group (CACG) from January 2018 to December 2018.

The CACG was established in 1998 to enable an effective exchange of information between Moorabbin Airport Corporation (MAC), local authorities, airport users and the local and broader community.

The CACG is an independently-chaired forum which meets quarterly to discuss issues and concerns relating to operations at Moorabbin Airport. The membership of the CACG consists of a broad cross-section of representatives from industry, regulators and the community.

The CACG is for consultation purposes only and is not a decision-making body. The purpose of the CACG is to:

- facilitate engagement between Moorabbin Airport, community representatives, local authorities, airport users and other stakeholder groups in relation to airport planning and operations
- allow airport planning and operational issues to be raised with the airport operator
- complement and support ongoing consultation on developments such as Master Plans, Airport Environment Strategies and Major Development Plans; and
- provide stakeholders with information regarding the airport and general aviation.

The Group discuss issues/concerns of the community at large and airport users regarding the operation and development of Moorabbin Airport. Matters for discussion may include, but are not limited to:

- the contribution of the airport to the local, regional and national economy
- · development of the airport
- airport operations
- ground transport and access to the airport
- · aircraft noise and environmental issues, including noise abatement
- reports by Airservices Australia and Civil Aviation Safety Authority (CASA)
- strategies to ensure the broad community is informed of issues discussed in the group and is encouraged to engage with Members to provide additional information and perspectives; and
- complaints handling procedures


Summary of Aircraft Noise Complaints (2018)

Complainants

There were 90 individual complainants in 2018. This is an increase from 85 complainants in 2017, but less than 2016 as shown in the chart below.

<u>Issues</u>

The main issues in 2018 were:


- General aviation traffic, 44 complainants
- Circuit training, both fixed and rotor wing, 24 complainants and
- Helicopter operations, 12 complainants.

A comparison of complainants under these main issues and night movements with the preceding two calendar years is provided in Chart 2 below.

The majority of complainants affected by General aviation traffic are affected by the standard arrival and departure routes to Moorabbin Airport. More information can be found under the Flight Paths tab.

Eighty percent of complainants affected by circuit training were concerned with fixed wing operations. One complainant was concerned with operations in the training areas.

<u>Suburbs</u>

Thirty-six separate suburbs across the greater Melbourne basin recorded complainants in 2018, and 24 suburbs recorded a single complainant.

Dingley Village recorded the most complainants (15) and as seen in the chart below this has been consistent over the last three years.


An increase in complainants occurred for the suburbs of Heatherton and Beaumaris.

Heatherton residents were affected by circuit training, standard operations on Runway 17 and one resident was affected by ground running at the airport.

Beaumaris residents were mainly affected by aircraft involved in instrument training at the airport and parachute operations. Both of these procedures involve aircraft circling over the area.

Conclusion

Moorabbin Airport's CACG meetings continue to be well supported by members of the local community, aviation operators and various government agencies. Members are actively engaging on agenda items and in group discussion.

Meetings were enhanced through briefings from guest speakers on a range of topics including community support and future infrastructure (Mordialloc Freeway Project).

Moorabbin Airport continues to play a vital community role as:

- Asia Pacific's largest flight training facility with multiple flying schools providing flight training to approximately 1,250 students annually;
- a place of employment with the airport estate being home to over 250 businesses providing approximately 5,000 jobs (with 60% of workers living locally);
- an investment centre driving economic growth;
- a vital medical access point for regional communities through the services provided by the Royal Flying Doctor Service and Angel Flights;
- home to the Westpac Rescue Helicopter Service;
- a hub for aerial bushfire support for the region;
- a facility accessed by emergency services and defence forces air wings units; and
- the home of the Australian National Aviation Museum.

Moorabbin Airport Corporation continues to invest in the Moorabbin Airport site and the surrounding community to maintain a compliant, safe and sustainable airport.
