
# February 2015 Information Update



### **Moorabbin Airport West Access Road - Phase 1**

## Location

Moorabbin Airport, Mentone, Cheltenham



# **Type**

Part (dead end) road within airport site accessed via a new signalised intersection on Lower Dandenong Road.

# **Project Overview**

Phase 1 of the Airport West Access Road is the first stage of a new connector road wholly within the Moorabbin Airport site for 2km between Lower Dandenong Road and Centre Dandenong Road.

The Airport West Access Road – Phase 1 will deliver a new 0.5 kilometre section of the airport access road that will terminate at a dead end within the airport site. Phase 1 works will not connect to the existing airport network.

The site for the road is within the south-west corner of the airport site and is bounded:

- to the north and west by the Airport Support Services and Operations Precincts;
- to the south by either Lower Dandenong Road or the rear boundaries of residential properties abutting that road; and
- to the west by either Bundora Parade or the rear boundaries of properties abutting that road

The on-airport stormwater detention basin will be constructed on airside land and is designed to minimise impacts of flooding in the area. The landscaping business, part of the area for more than 40 years, is being relocated on airport land 100m to the east.

Please note that these works are relating to the access road and stormwater drainage infrastructure only. We advise that the Two Warehouses and Office project is a separate project and information updates will be provided separately.

## **Status**

- Moorabbin Airport Corporation, as the consent authority under the Airports (Building Control) Regulations 1996, issued consent on 2 September 2014 for the works on the airport only.
- Airport Building Controller issued a issued a Works Permit on 12 January 2015.

Construction is expected to start in February 2015 and will take around 6 months to complete.

All work is to be undertaken as per an approved Construction Environment Management Plan. Construction works may be carried out between the hours of:

- 7am to 6pm Monday to Friday
- 7am to 1pm Saturdays 1pm

No works on Sunday or Public Holidays.

# Construction Program & Activities West Access Road – Phase 1

The construction activities are currently anticipated to be undertaken as follows:

Quarter One 2015 (Feb – March):


- Earthworks (strip and filling of Warehouse and Office site.)
- Replacement of boundary fencing
- Commencement of water, sewer, drainage infrastructure

#### Quarter Two 2015 (April – June):

- Road formation and construction including kerb and channeling, and asphalting
- Intersection works on Lower Dandenong Road
- Services installation including data and power

#### Quarter Three 2015 (July – September):

- Construction of footpaths and driveways
- Completion of intersection works on Lower Dandenong Road
- Top soiling and site stabilisation
- Handover.
